ARTS & CRAFTS FESTIVAL

MASON, TEXAS

July 10th 2020 - Saturday 9:00 AM to 3:00 PM

We invite you to participate in the Mason Roundup Weekend Festival. Other activities in Mason will be a street parade, kid's races, Rodeo Queen Contestants' presentation, and live entertainment on the historic courthouse lawn.

Location: Mason County Heritage Park, right off town square on Moody Street

Booth: Size 10' X 12' - Cost: \$60.00 per booth for those residing outside Mason County.
\$45.00 per booth for Mason County residents. \$20.00 per booth for civic or charitable organizations.

Booths will be assigned and reserved in paid registration sequence. Applications and fees should be postmarked by June 25, 2021. Food booth spaces are available. There is limited electricity available. If needed, this will be an additional \$10.00 fee per plug. All food and vending trucks or trailers will not be eligible for electricity, generators are recommended. Your booth assignment will be posted on the information board upon arrival. There will be no refunds after June 25th and no rain dates. We reserve the right to cancel any event in accordance with the restrictions provided by our federal, state, and county governments regarding COVID-19.

Set Up: You may set up between **3 PM and 6 PM on Friday, July 9th or starting at 7:00 AM on Saturday, July 10th**. All exhibitors must be set up by 9:00 A.M. on Saturday and remain set up until 3:00 P.M.

Participation Rules:

1. Exhibitor must provide own display equipment including tables, chairs, & heavy-duty extension cords if electricity is needed.
2. **Craft Vendors:** No commercial or imports. In an effort to maintain show quality, first time exhibitors are required to send at least 3 photos of their work. Exhibitors who have substantial changes will be required to submit new photos. We reserve the right to bar items or activities in bad taste, that are inappropriate, or that do not meet the rules. We reserve the right to limit duplications of the same craft items and a decision will be made, assuming equal quality, on a first-come, first-served basis.
3. **Food Vendors:** The food vendors will be set up on the upper-level Museum parking lot and grass, food trailers to set up on east parking lot shaded area of museum like a food court type area if you need space in front of trailer for serving you may set up 10x15 space on asphalt parking lot. For our files, we would like to have at least one picture of your trailer or setup if you are a new vendor. We reserve the right to limit duplications of the same food items and a decision will be made, assuming equal quality, on a first-come, first-served basis.
4. Shade is limited and is **NOT** guaranteed. Please bring a canopy or other covering.
5. Exhibitor must secure booth display against wind. You are responsible for any damage caused by your display to other exhibitors' merchandise or to customers.
6. Exhibitor is responsible to collect and report their own sales tax. Tax rate in Mason is 8.25%.
7. Exhibitors are expected to be present throughout the normal scheduled hours of the show. Exhibitor must contain trash and leave booth area clean at the end of the day.
8. **NO** pets on the lawn.
9. To sell any edible items, however packaged, exhibitors must provide proof of church affiliation, IRS 501c or non-profit status or Texas State Department of Health permit. Contact show chairman for details.
